### Abstract guideline

The abstract structure must follow below instructions:

Language: The abstract must write in both language English and Persian
Detail: The personal details of the author's phone number, mobile phone and e-mail are required.
Abstract deadline: The deadline for the abstracts is 2020 june 20.
Text: Font & size: Times New Roman Font, size 12, single paragraph
Line Space: Single space
Word count: Not more than 700 words
Title: no more than 90 characters (Bold and font=14).
Author name (s): First author's First Name, First Author Last Name1; Second author's First name, second author's Last Name2; and so on as well as Contact details of the Author(s) (Bold and font=12).

Additional information including individual

- 1. Abstracts should be submitted via e-mail<sup>1</sup> as an attachment in Word format.
- Abstracts must include enough information for reviewers to judge the nature and significance of the topic, the adequacy of the investigative strategy, the nature of the results, and the conclusions. The abstract should summarize the substantive results of the work and not merely list topics to be discussed.
- 3. The Corresponding Author (marked by \*) is responsible for:
- the ensuring that all listed authors have approved the manuscript before submission, including the names and order of authors.

- the manuscript correction, proof reading, whole correspondence during the paper submission, handling the revisions and re-submission of revised manuscripts up to the acceptance of the manuscripts.
- managing all communication between the conference organizer and all co-authors, before and after acceptance.

Each abstract must include the 7 division: Title, Author names, Introduction, Material and methods, Results and discussion, Conclusions, and at least 5 keywords (Table, figure and supplementary data is optional).

#### **Additional information:**

- 1. Abbreviations should be defined at the first time they appear in your text before being used as an abbreviation. E.g.: Food & Agricultural Organization (FAO).
- 2. Do not define or use abbreviations in the title.
- 3. Avoid complex mathematical formulas, footnotes, endnotes, references etc. in your abstract.

#### **Common reasons for abstract rejection**

- 1. Subject matter is not appropriate for the seminar
- 2. Information is outdated and does not add new knowledge to the scientific field
- 3. Abstract is duplicative of other submissions
- 4. Submission is poorly written and difficult to understand
- 5. Poor description for materials and methods
- 6. Statistical description and evaluation is inadequate or absent
- 7. Summary of essential results is inadequate or absent
- 8. Data are not included or sample size inadequately supports conclusions
- 9. Copyright infringement
- 10. Poor English writing
